In Australia the drowning of children under the age of five years is the nation's biggest accidental killer and the Royal Life Saving Society Queensland is working towards reducing this figure through its Love2Swim program.

Still water environments account for the majority of these tragedies and our Love2Swim website provides a unique introduction to the provision of information on general water safety education and lifesaving advice to the community in general.

Royal Life Saving Society - Australia and The Alliance for Safe Children, the hosts of the next International Life Saving Federation conference have launched a website promoting this fast approaching event. The World Conference on Drowning Prevention 2011 will be held in Danang, Vietnam, 10-13th May 2011. The conference aims to focus world attention on the global burden of drowning with a specific emphasis on the epidemic number of drowning deaths in developing countries.

The World Conference on Drowning Prevention 2011 website has several features designed to build interest in the conference and the issue of drowning as we work towards Danang, including a news service, venue information and a database of Conference Ambassadors. The hosts also aim to build a knowledge base of resources, projects, research and organisations, all focused on reinforcing the need for coordinated global advocacy to reduce drowning.

Tragically, more than 11,000 children drown in Vietnam each year. Typhoons cause heavy rain, flooding and storm surges that make preventing drowning a major priority to central and regional governments.

The conference will also include a visit to the SwimSafe Danang teaching sites to show the conference participants the first hand response to preventing the child drowning epidemic in Vietnam and the Asian region.

Competency Based Workshops

Workshop enrolment forms will be available on the website by the end of May.
Current trainers will be emailed the workshop enrolment form and trainers' application form.

Which Workshop Should I Attend?

There are two workshops occurring this year for competency based trainers. To decide which you should attend, please read through the following information on each workshop.

Important change – your accreditation will only be updated for those qualifications that you are currently endorsed as a trainer for with the exception of the Resuscitation award, which all participants will be required to complete.

If you hold a qualification (e.g. pool lifeguard, oxygen equipment etc) but are not endorsed as a trainer, you will not be able to use this as an update.

Please also complete a new trainer application for the 2010/2011 financial period and send it in with your Workshop Enrolment Form. If we receive your trainer application prior to the workshop we will be able to issue you with your new 2010/2011 trainer number and requalification certificates at the Professional Development Workshop.

Combined Trainer Workshop - The Southport School - Monday, 5th July 2010

- This workshop covers all the courses we deliver. Options will be available for first aid, resuscitation, oxygen equipment, bronze medallion and pool lifeguard.
- Bronze and Pool lifeguard trainers will be required to actively participate in the water based sessions.
- Additional sessions for recreational trainers who want to become competency trainers will also be available.

First Aid Trainer Workshop - The Plantation - Saturday, 24th July 2010

- This workshop is for any trainers delivering resuscitation, first aid and oxygen equipment.
- This workshop contains no water based content and is not suitable for Bronze or Lifeguard only trainers.

Note

- A new points system for becoming a Royal Lifesaving Society Qld registered trainer and maintaining your trainer status will be implemented in the 2010/2011 season.
- This system will be explained at this year's professional development workshops.
