LETTER FROM THE PRESIDENT

The 2019/2020 summer is almost over, however it will be solemnly remembered as one of the most catastrophic for our island nation.



Bushfires have scared millions of hectares of land, destroyed thousands of properties, and taken many innocent lives.

Since August, thirty-two (32) lives have been lost in the inferno, including three members of an American firefighting crew, who were killed when a C130 air tanker crashed to the west of Cooma, on Thursday 23 January 2020.

During that week, the Royal Life Saving Society of Australia released another staggering statistic. The summer national drowning toll had reached fifty-eight (58). This extraordinary record of loss of community life, by accidental death by drowning, was beyond belief.

Still some areas of the state are experiencing drought, and now the coronavirus is making it's mark on the community. Seems as though we are living from one tragedy to the next.

Amongst all of this, I really do hope that the year ahead provides moments of joy and happiness for all of our members, as we continue to strive to get the great programs of the Royal Life Saving Society to all Queensland communities.

LETTER FROM THE EXECUTIVE DIRECTOR

The training and aquatic industry is challenged by change, with more change impacting the industry over the last twelve months, than has probably occurred over the preceding ten years. The main changes that are impacting us including at the present time are:



The <u>Guidelines for Safe Pool Operation</u> with a new Aquatic Supervision guideline which has had significant change to the former guideline. The Low Patronage policy has been removed with all

aquatic facility's now required to prepare a Supervision Plan. At our Aquafutures conference (August 2019) we provided an <u>example supervision plan</u>. The feedback form most operators that have prepared a plan, tell us that considerable work is involved and it seems to take two weeks to prepare an initial plan.

Queensland Health have issued a revised <u>Water Quality Guidelines for Public Aquatic Facilities</u>. The purpose of this guideline is to reduce risk to public health and the focus is on water quality associated risks. Following the release of this guideline, Royal Life Saving has released a <u>Position Statement</u> in respect to operator training and operators of high risk aquatic centre are strongly advised to hold a <u>Cert IV in Swimming Pool & Spa Service (CPP41319)</u>. This course is by no means a small or simple course and will take most participants six months to fully complete. Royal Life Saving has the first course commencing on Monday 20 April 2020.

Australia Skills Quality Authority (ASQA) have issued two important documents:

- A <u>Direction on Third Party Arrangements</u>: This has caused us to look at our operating model for trainers as some of our processes may no longer comply with the direction. This is primarily in respect to registration of participants for courses and payment for courses.
- A <u>Fact sheet on Marketing</u> which impacts all trainers and how trainers communicate with students. We subsequently issued a <u>Guideline for Trainers</u> to assist trainers comply with the ASQA requirements.

Lastly a number of units of competence are being revised and updated. The main changes for Royal Life Saving are:

- Low Voltage Rescue Unit of Competence has been re-issued to a new unit (UETTDRRF06 Perform Rescue from a Live LV Panel).
- All health units (i.e. CPR & First Aid) are about to be re-issued with some minor changes. All units in the health package will have new unit codes.
- The Oxygen Units (PUAEME001B Provide Emergency Care and PUAEME003C Administer Oxygen in an Emergency Situation) are being reissued and include training for Suction Device which will be rolled out very soon. The Pool Lifeguard Re-accreditation will be amended to a Pool Lifeguard Update which will include the new units.

This year looks like it will be a very busy year for Royal Life Saving and the aquatic industry and the changes will bring challenges for us all. Royal Life Saving as a peak body will continue to support and lead the industry as we proceed through the changes so that we can work towards reducing drowning in Queensland.

LETTER FROM THE MANAGER

2020 is a new year, a new decade and a new opportunity for us to deliver the important message of water safety across Queensland. In the first term of the year we will be delivering an eight week water safety education program to international stude

at Kedron State High School. This program will follow the Swim & Survive framework and focus on equipping students with important water safety and CPR knowledge and skills.

We have been fortunate enough to receive funding from the Department of Home Affairs to design and deliver our latest project, the Swimming for Integration series. This project has been specifically designed to target females and children and will aim to engage migrants in an aquatic program that will ensure they have the opportunity to integrate into the life of their local community. Across Queensland we will be running these programs in Townsville, Cairns and as a part of the Toowoomba Multicultural Youth Program and Women's Learn to Swim Program.

The Swimming for Integration series has a heavy focus on promotion of social wellbeing and inclusion in community life. This will be encouraged through the provision of Learn to Swim lessons and access to a variety of aquatic programs. The intention is for the local aquatic centre to become a focal point of social interaction which will in turn increase the access of migrants to community life. The series will also work to develop the cultural competency of the aquatic industry by creating awareness and understanding of the social and civic needs of migrants. In turn, educating the aquatic industry as to how they can meet and exceed these needs. Finally, the program should develop awareness and understanding within the settlement sector of the role that aquatics can undertake in integrating migrants into Australian life.

The diverse and encompassing goals of the program have encouraged us to select a range of strategies. Specialised swimming lessons will be offered by a qualified Swimming and Water Safety Instructor.

These lessons will focus specifically on adult women and young people, the target group of the project. A total of 10 lessons will be offered to each participant, as well as

allocated recreation and practice time. At the finish of the program, a graduation event will be conducted with family and friends.

We will also be delivering the Move It Australia program over 10 weeks in Townsville. This program will target inexperience swimmers of all ages by giving them the opportunity to learn and practice skills that will enable them to safely participate in a range of physical activities. Finally, Uncle Tobys has generously funded the Swim My Way program to run in Rockhampton. The short intensive program has been designed to engage children in the broader community in learning and practicing water safety skills.

Accompanying these major projects will be a range of smaller projects across the state. We have an exciting year ahead of us and are looking forward to the immense and positive impact that we will be able to have on our community.

PROJECTS UPDATE

The Spring and Summer period has seen our projects team busy delivering projects all over Queensland. We have been able to reach hundreds of people across the state, have been asked to revisit several of our projects in the coming year and have received some fantastic feedback along the way.

Mount Cotton State School

Mount Cotton State School is a primary school that operates in the centre of a rural community. Over the last school term our projects team travelled to Mount Cotton every Friday to deliver water safety and survival skill sessions to year 4, 5 and 6 students. Our delivery was highly praised by teachers and students. We



have been fortunate enough to be asked to return in 2020 and are currently arranging dates with this school. We hope to form an ongoing partnership with this school to enable a continued community education link.





Kedron State High School

Kedron State High School is a secondary school which operates an International Student Program in conjunction with Education Queensland International. This program caters for between 45 and 50 students from all over the world. In addition to this, the school has many students who speak English as a second language.

Royal Life Saving Queensland collaborated with the school to develop a sustainable and flexible program which meets the diverse needs of the student group. This program was focused on water awareness, water safety education and survival skills. It entailed pool sessions, open water sessions, a water safety ambassador visit to the school and PD sessions for the teachers who were a part of assisting the delivery of the sessions.

We have received positive reviews from Kedron State High School regarding the delivery of this project and have been asked to return in 2020.

Redcliffe Special School

Redcliffe Special School is a secondary school which provides education to students with a suspected or verified disability. Students have a primary intellectual impairment but may also have secondary disabilities such as a physical, hearing or vision impairment.

In December we completed a water safety education day at Redcliffe Special School. On this day we were able to speak to the entire school across three sessions. We took on an interactive approach with students, asking them to point out dangers that they may see at creeks, rivers, pool, beaches and lagoons and then getting them to tell us how they would stay safe at these places. While students loved getting to tell us how they apply water safety, their favourite part of the session was by far getting to meet a Lifeguard. It was fabulous to see the smiling faces of the children and engagement in the sessions.

We have also been working with Redcliffe Special School to create a program which caters to the diverse needs of their students. This program will commence in 2020 and we are excited at the opportunities it holds for the students involved.



ROMA PROFESSIONAL DEVELOPMENT WORKSHOP

On Saturday 21 September 2019, Royal Life Saving partnered with AUSTSWIM to deliver a professional development workshop in Roma. Explaining the opportunities surrounding Swim & Survive, the Junior Lifeguard program, Rescue awards and e-Lifesaving, attendees were enlightened on numerous potential areas of growth to their current programs. The Keep Watch, Respect the River and Don't Let Your Mates Drink and Drown campaigns were also all delivered successfully, enhancing the education of aquatic industry leaders in our rural communities.

NATIONAL AQUATIC INDUSTRY WORKFORCE PROFILE

The National Aquatic Industry Workforce Profile was published by Royal Life Saving in late December 2019. Highlighting key statistics from data collected in the National Aquatic Industry Workforce survey, the document provided a deeper insight into the current makeup of the aquatic industry and how this industry could potentially grow and develop in the coming years.



Currently, the industry is estimated to involve 67,000 workers, with 73% of this population being female. Generally, members of the workforce were found to work casually throughout

the year, with many having a second job or completing study simultaneously. A highlight of the profile was the consensus that most workers valued their role due to the knowledge of the positive impact that it has on the lives of the greater community.

SWIM READY

As we age, we become more susceptible to a range of chronic medical conditions including heart diseases, diabetes, mental health and dementia. This increases the likelihood that we require prescription medications to handle our conditions. However, as we age our bodies also begin to process these medications differently which can alter the impacts, both positive and negative, that they have on our body. Further, with more than one condition we may require more than one medication which can lead to multiple drugs interacting and affecting each other.



Extensive research into the drowning data from 2008 to 2018 suggested a correlation between unintentional fatal drownings in the older population and the use of medications or drugs. <u>Swim Ready</u> aims to educate the older population on how use of medication can increase their risk of drowning.

The Royal Life Saving Society Queensland has actively been involved in spreading the <u>Swim Ready</u> key messages through a number of platforms. This has included interview for Channel 7 which we hope that you were able to view.

SUMMER DROWNING TOLL

As Summer approaches and the temperature climbs, the appeal of our pools, beautiful beaches, rivers and dams greatly increases. With increased swimming over this Summer period, this can often be the time of the year with the most drowningrelated devastation.

How are these drowning deaths distributed across Australia?	
ACT - 0 (0%)	SA - 3 (6%)
NSW - 25 (47%)	TAS - 1 (2%)

In the 2018-2019 summer period, 94 drowning deaths were recorded across Australia. As of February 4 2020, the Royal Life Saving Summer Drowning Toll currently sits at 53, with 89% of these deaths being male. We are pleased to see a decrease in this number compared to that of last year. However, our hearts go out to the families, friends and communities who have lost loved ones over this time. We encourage everyone that is swimming or taking part in water activities over the root at the Summer to stay, safe, and head to the material of a summer to stay.

MAKE THE RIGHT CALL

Royal Life Saving with the Australian Government has launched the 'Make the Right Call' campaign for summer. This campaign aims to target susceptible demographics by giving the simple message to "Make the Right Call". 40% of all drownings occur in inland waterways. Of these, 80% of deaths are male, and 32% involve alcohol. Over the past ten years, 2,855 people have lost their lives to drowning and many more non-fatal drownings have occurred.

We are asking the public to "Make the Right Call" and remember these messages:

- Avoid alcohol around water
- Wear a lifejacket (when boating or on watercraft)
- Never swim alone
